THE PUBLIC PROCUREMENT APPEALS RULES (GN. No. 411 OF 2014)

RULES

(Made under section 105)

THE PUBLIC PROCUREMENT APPEALS (AMENDMENT) RULES, 2017

Construction GN. No. 411 of 2014

1. These Rules may be cited as the Public Procurement Appeals (Amendment) Rules, 2017 and shall be read as one with the Public Procurement Appeals Rules, 2014 hereinafter referred to as the "principal Rules".

Amendment of Rule 3

2. The principal Rules is amended in rule 3 by inserting in it alphabetical order the following definition:-

""application" means a formal request in writing, made by the applicant for a certain order before the Appeals Authority;".

Amendment of Rule 6

3. The principal Rules is amended in Rule 6 by:-

- (a) adding the reference to section "59(2)" immediately after the word "sections" appearing in the open words to Rule 6;
- (b) adding the word "unjustified" before the word "rejections" appearing in paragraph (g).

Revocation of

Rule 8

4. The principal Rules is amended by revoking Rule 8.

Amendment of Rule 9

5. The principal Rules is amended in Rule 9 by deleting the word "fourteen days" and substituting for it the word "seven working days" appearing in sub-rule (1).

Amendment of Rule 10

6. The principal Rule is amended in Rule 10 by deleting subrule (1) and substituting for it the following:-

"(1) The appeal under Rule 8 shall be in writing or in electronic form and shall be filled in accordance with PPAA Form No. 1 as set out in the First Schedule to these Rules".

Amendment of Rule 11

7. The principal Rules is amended in Rule 11 by deleting the word "No. 7" and substituting for it the word "No.6".

Amendment of Rule 12

8. The principal Rules is amended in Rule 12 by:-

- (a) inserting the phrase "in the format set out in Form No.2 prescribed in the First Schedule" between the words "submission" and "to the Appeals" appearing in sub-rule (2):
- (b) revoking sub-rule (3) and (4);
- (c) renumbering sub-rules (5) and (6) as sub-rules (3) and (4) respectively; and
- (d) deleting sub-rule (4) as renumbered and substituting for it the following.
 - "(4) A tenderer may, at any time before the hearing of the appeal and upon filing a statement indicating reasons thereof, join as a party to the proceedings:

Provided that no statement shall be entertained by the Appeals authority if it is lodged less than three working days before the hearing date".

Amendment of Rule 13

9. The principal Rules is amended in Rule 13(2) by deleting the word "five days" appearing in paragraph (b) and substituting for it the word "three working days".

Amendment of Rule 17

10. The principal Rules is amended in Rule 17 by deleting the words "in its discretion," appearing in sub-rule (1) and

substituting for it the words "on its own motion".

Amendment of Rule 18

11. The principal Rules is amended in Rule 18 by deleting the words "Form PPAA No.4" and substituting for it the words "Form PPAA No.3" appearing in sub-rule (2).

Amendment of Rule 20

- 12. The principal Rules is amended in Rule 20 by:-
- (a) deleting the word "No.6" appearing in sub-rule (2) and substituting for it the word "No.5";
- (b) deleting the phrase "Form No.8 as set out in the First schedule" appearing in sub-rule (3) and substituting for it the following phrase: "Form No.7 as set out in the First Schedule."

Amendment of Rule 23

13. The principal Rules is amended in Rule 23 by deleting the word "No.5" appearing in sub-rule (2) and substituting for it the word "No.4".

Amendment of Rule 27

- 14. The principal Rules is amended in Rule 27 by:-
 - (a) adding the word "working" between the words "seven" and "days" appearing in sub-rule (1); and
 - (b) adding the word "working" between the words "seven" and "days" appearing in sub-rule (4).

Amendment of Rule 28

15. The principal Rules is amended in Rule 28 by deleting figure "10" and substituting for it with figure "9".

Amendment of Rule 30

- 16. The principal Rules is amended in Rule 30 by:-
 - (a) deleting sub-rule (2) and substituting for it the following:-
 - "(2) The respondent shall file his reply, if any, within five working days from the date of receipt of the statement of appeal."
 - (b) deleting the word "3 days" and substituting for it the phrase "three working days" appearing in sub-rule (3);
 - (c) deleting the phrase "Form No.5 as set out in the first Schedule" appearing "form No.4 as set out it the First Schedule".

General amendment

17. The principal Rules is amended by renumbering Rule "9, 10, 11... 33" as Rule "8, 9, 10...31" respectively.

Additional of new Rule 32

18. The principal Rules is amended by adding immediately after Rule 31 as renumbered the following new Rule 32 as follows:-

"Execution of the decision

- 32.-(1) A decree holder of the decision of the Appeals Authority shall execute the decision by making an application to the Appeals Authority using PPAA Form No.7 and the Appeals Authority shall issue a decree or order authorising execution.
- (2) Execution of the decree or an order issued by the Appeals Authority shall be carried out in accordance with the provisions of the Civil Procedure Code.

Cap.33

- (3) A decree shall be extracted from the decision of the Appeals Authority and shall be signed by the Chairperson of the Appeals Authority or their successor in office, as the case may be, or the Executive Secretary.
- (4) The decree shall contain, among other things, the Appeal case or registration number, the names and descriptions of the parties and particulars of the claim, and shall specify clearly the award or reliefs granted or other determination of the appeal.
- (5) Notwithstanding sub-rule (1), No application for execution shall be entertained by the Appeals Authority until after the expiry of fourteen days from the date on which a decision or order of the Appeals Authority was made".

Amendment of the Schedule

- 19. The principal Rules is amended in the Schedule by:-
 - (a) deleting the enabling provisions and substituting for it the following:-

"(Made under Rules 9, 10, 11, 13, 17, 19, 22, 29 and 33)";

- (b) deleting PPAA Form No.1; and
- (c) renumbering PPAA Form No.2 to PPAA Form No.8 as PPAA Form No.1 to PPAA Form No.7 respectively.
